



Emergency Medical Technician: Paramedic Program

Information and Application Packet 2017-18

Program Description

Paramedics are on the front-line of emergency medical care, and Schoolcraft can help students prepare for a career in this fast-paced profession by earning either a certificate or an associate of applied science degree.

- Paramedic courses are offered at the Radcliff Center in Garden City.
- The paramedic certificate prepares students for employment as a pre-hospital emergency medical provider, while the associate in science degree enables students to qualify for a job as an emergency provider. The rigorous programs include a combination of lecture, laboratory, clinical and internship experience to give students a solid foundation in the field of emergency medical technology. Every course is approved by the Michigan Department of Community Health EMS and Trauma Systems Section.
- Students achieving an 80 percent or higher in the required courses will receive a certificate of completion and be eligible to test for state licensure.
- Credits earned in the certificate program will count toward the Paramedic AAS degree and may transfer toward a bachelor's degree at a four-year college or university. Students should work closely with a counselor or advisor to ensure best course transferability.

Application Requirements

The Emergency Medical Technician -Paramedic Program requires an application (attached to the end of this packet). To be admitted to the program the student must complete the following:

1. Apply to Schoolcraft College	Apply to Schoolcraft College on-line at www.schoolcraft.edu .
2. Transcripts	It is recommended you request official undergraduate transcripts from <u>all</u> colleges and universities previously attended. Transcripts must be sent directly from the issuing college or university to Schoolcraft College. To confirm that transcripts have been received, contact the Answer Center at 734-462-4426.
3. Counseling and Assessment	This program requires minimum assessment levels or course work in the areas of math, reading and writing. Students need to meet with an academic advisor or counselor to develop an academic plan. They can determine if an assessment test is necessary and if foundation courses are needed. Students with prior college level work or a degree may be exempt from placement testing. Students who have submitted SAT or ACT scores that are less than three years old to the Admissions and Welcome Center may also be exempt from assessment testing. 4. BIOL 101	Complete one semester of General Biology with a grade of 2.0/C or better. You may complete an equivalent college course to satisfy this requirement
5. BIOL 236 or 237 and 238	Complete one semester of Human Anatomy and Physiology with a grade of 3.0/B or better. You may complete an equivalent college course to satisfy this requirement.
6. EMT 115	Complete Emergency Medical Technology--Basic with a grade of 2.7 or better. You may present a valid State of Michigan EMT-Basic License to satisfy this requirement.

7. Cumulative GPA	Attain a cumulative grade point average of <u>2.0</u> or better for all Schoolcraft College courses.
8. Apply to Emergency Medical Technician: Paramedic Program	Submit the attached Emergency Medical Technician: Paramedic Program Restricted Enrollment to the Registration Center with appropriate signatures.
